





Passenger Rail Service Complaints 2019-20 Q1 Statistical Release

Publication date: 24 October 2019
Next publication date: 9 January 2020

Background

This release contains information on complaints made by passengers regarding rail services in Great Britain. This covers:

- Complaints rate per 100,000 journeys, including by train operator;
- Complaint categories;
- Complaint response time within 20 working days;
- Appeals made to passenger watchdogs.

The latest **quarterly** statistics for 2019-20 Q1 refers to April, May and June 2019.

Annual statistics for 2018-19 can be found in the previous <u>statistical</u> <u>release</u>. There were 24.9 complaints per 100,000 journeys for franchised operators in 2019-20 Q1, a decrease of 15.7% compared to 2018-19 Q1.

Punctuality/reliability of rail services remains the largest category of passenger complaint in 2019-20 Q1. The largest percentage point (pp) increases in 2019-20 Q1 compared with last year were for complaints regarding facilities on board the train (up 3.7 pp).

Appeals – <u>p8</u> Annexes – <u>p10</u> Nationally, 98.6% of complaints were closed within 20 working days during 2019-20 Q1. A total of 21 out of 23 train operators met the industry requirement to close 95% or more of their complaints within 20 working days.

There were 394 appeals closed by passenger watchdogs in 2019-20 Q1, a decrease of 74% compared to last year. The reason for this decrease is due to a number of appeals directed to the new Rail Ombudsman instead of Transport Focus and London TravelWatch.

Rail complaints rates 2019-20 Q1

A complaint in the rail industry is any expression of dissatisfaction by a customer or potential customer about service delivery or about company or industry policy. All the complaints data contained within this release are sourced directly from the train operating companies. In the complaints rate statistics each communication with the customer is counted as a single complaint, regardless of how many topics are covered in the communication.


The complaints rate is the volume of complaint correspondences closed per 100,000 passenger journeys. Complaints are normalised by passenger journeys to allow effective comparisons of data between time-periods and train operating companies.

Social media comments are excluded from these statistics. The number of complaints received via such sources, the definition of a 'complaint' and the resources that each train operator allocates to these social platforms vary significantly, and therefore they are excluded from the published figures.

- There were 24.9 complaints per 100,000 journeys for franchised operators in 2019-20 Q1, compared to 29.5 complaints per 100,000 journeys in 2018-19 Q1. This represents a 15.7% decrease and has led to 2019-20 Q1 being the lowest quarterly complaints rate since 2015-16 Q1.
- The decrease in complaints rate follows an increased number of complaints in 2018-19 Q1 due to the disruption caused by the May 2018 timetable changes.

Complaints per 100,000 passenger journeys (franchised operators only), Great Britain, 2012-13 Q1 to 2019-20 Q1 (Table 14.8)



■ There were 30.9 complaints per 100,000 journeys for **non-franchised operators** in 2019-20 Q1 a 70.5% decrease compared to the same quarter last year (these operators were Hull Trains, Grand Central and Heathrow Express). If these non-franchised operators are included, the national complaints rate in 2019-20 Q1 is 24.9 complaints per 100,000 journeys.


Long-term trend

There has been a long-term decline in the complaints rate since the time series began in 1998-99. In 2018-19, there were 30.1 complaints per 100,000 journeys, which was a 75% lower than the complaints rate in 1998-99. For further information on long-term trends, see the 2018-19 Q4 release.

Complaints rate by train operator 2019-20 Q1

- Caledonian Sleeper had the highest complaints rate in 2019-20 Q1 with 206 complaints per 100,000 journeys, followed by Virgin Trains West Coast and London North Eastern Railway with 143 and 127 complaints per 100,000 journeys respectively.
- There were eight train operators that had a higher complaints rate in 2019-20 Q1 compared with 2018-19 Q1, and there were 15 train operators that had a lower complaints rate.

Note: East Midlands Trains is operating as East Midlands Railway as of 18 August 2019. This name change will be reflected in our next publication which covers Q2 2019-20.


Complaints by category 2019-20 Q1

Complaint by category: The type of complaint received, where each complaint category within the correspondence should be recorded. For example, a letter covering two complaints is counted as two complaints categories. However, this would only be recorded as one complaint correspondence within the complaints rate.

There are 71 detailed categories, mainly based on National Rail Passenger Survey (NRPS) satisfaction categories, which make up 14 high-level complaint categories.

- Punctuality/reliability of rail services was the most common cause to complain to train operators. Overall, 17.6% of complaints nationally in 2019-20 Q1 were about punctuality/reliability, though this was a 4.6 percentage point (pp) decrease compared with 2018-19 Q1.
- Complaints regarding the facilities on board the train remained the second most common cause of complaint in 2019-20 Q1, at 12.1% of all complaints (up 3.7 pp from 2018-19 Q1). Sufficient room for all passengers to sit/stand remains the third most common cause of complaint, at 8.1% of all complaints (up 1.2 pp from 2018-19 Q1).

Largest increases/decreases in complaint categories between 2018-19 Q1 and 2019-20 Q1

■ The largest increase in 2019-20 Q1 compared to the previous year was regarding facilities on board the train, where 12.1% of all complaints were attributed to this category, up 3.7 pp from 2018-19 Q1.

- The largest decrease in 2019-20 Q1 compared to the previous year was regarding punctuality/reliability of rail services, where 17.6% of all complaints were attributed to this category, down 4.6 pp from 2018-19 Q1.
- Timetabling was the second largest decrease in 2019-20 Q1, down 3.3 pp from the same quarter last year to 1.6%. This is largely because of the increase in timetabling complaints during 2018-19 Q1 following the disruption caused by the May 2018 timetable changes.



Complaints answered within 20 working days 2019-20 Q1

- Nationally, 98.6% of complaints were closed within 20 working days in 2019-20 Q1. This is 3.7 percentage points (pp) higher than in 2018-19 Q1.
- In 2019-20 Q1, 21 out of 23 train operators met the industry requirement to close at least 95% of their complaints within 20 working days. This has increased from 18 out of 23 train operators that met the industry requirement in 2018-19 Q1.
- Northern, Hull Trains and Greater Anglia have seen the largest increases in their complaints response rates during 2019-20 Q1 compared to the same quarter last year.

Key changes for selected operators during 2019-20 Q1

Long-distance train operators have the three largest complaints rates in 2019-20 Q1, Caledonian Sleeper (206 complaints per 100,000 journeys), Virgin Trains West Coast (143 complaints per 100,000 journeys) and London North Eastern Railway (127 complaints per 100,000 journeys). This trend is consistent with previous data and is representative of the fact that long-distance operators receive more correspondence about their services.

Caledonian Sleeper had the largest increase in complaints rate from 2018-19 Q1 (up 67%) while **Hull Trains** had the largest decrease in complaints rate from 2018-19 Q1 (down 75%). All three non-franchised train operators (**Hull Trains**, **Heathrow Express** and **Grand Central**) saw decreases in their complaints rates (75%, 74% and 63% respectively).

The number of train operators responding to at least 95% of complaints within 20 working days has significantly increased in 2019-20 Q1 compared to 2018-19 Q1. The only train operators that did not meet this requirement were **c2c** (90.3%) and **London North Eastern Railway** (94.2%).

There were five operators which increased their complaints response rate compared to Q1 last year so that they responded to at least 95% of complaints within 20 working days in 2019-20 Q1: **Northern** (up 40 pp), **Hull Trains** (up 25 pp), **Greater Anglia** (up 14 pp), **Great Western Railway** (up 8 pp) and **Caledonian Sleeper** (up 4 pp).

There were four train operators that responded to all their complaints within 20 working days (i.e. 100%): CrossCountry, Heathrow Express, Southeastern and TransPennine Express. Additionally, Merseyrail and Govia Thameslink Railway responded to 100.0% of complaints rounded up to one decimal place.


Appeals 2019-20 Q1

Appeals closed: the number of complaint appeals closed by Transport Focus or London TravelWatch for each train operating company (including all non-franchised operators) and some other rail bodies. The data also includes the number of appeals in each complaint category.

The independent passenger watchdogs may open an appeal on behalf of a rail passenger whose initial complaint to the train operating company has not been resolved to their satisfaction.

- Passenger watchdogs closed 394 appeals during 2019-20 Q1. This was 74% lower than the volume of appeals closed during 2018-19 Q1.
- From 26 November 2018 (during 2018-19 Q3) the Rail Ombudsman started and provides a passenger service for unresolved customer complaints within the rail industry. As a result, many appeals are now being dealt with by the Rail Ombudsman instead of Transport Focus or London TravelWatch. This consequently has meant the number of appeals dealt with by Transport Focus or London TravelWatch has sharply decreased in the most recent two quarters.

Appeals closed by Transport Focus or London TravelWatch, Great Britain, 2015-16 Q1 to 2019-20 Q1 (Table 14.15)




Note: The dotted line displays a break in series where some appeals are now being dealt with by the Rail Ombudsman instead of Transport Focus or London TravelWatch

Appeals by category

- Appeals about punctuality/reliability of rail services remain the most appealed about complaint category with 25.5% of appeals closed being about this category in 2019-20 Q1. This was a 5.5 percentage point (pp) increase between the same quarter last year and was the largest percentage point increase of any complaint category.
- Appeals about ticketing and refunds policy remains the second most appealed about complaint category with 18.0% of appeals closed being this category in 2019-20 Q1, a 4.3 pp increase compared to the same quarter last year. Appeals about the complainant being unhappy at type/level of compensation saw the largest pp decrease in 2019-20 Q1, a decrease of 4.0 pp from the same quarter last year, to 7.9% of all appeals.
- The type of appeals dealt with by Transport Focus and London TravelWatch have changed since the Rail Ombudsman was introduced. For example, appeals regarding ticketing and refunds policies are 'out of scope' for the Rail Ombudsman so are dealt with by Transport Focus or London TravelWatch, but appeals about the complainant being unhappy at type/level of compensation are 'in scope' for the Rail Ombudsman. Therefore, comparisons on appeal categories with previous years should be treated with caution.

Annex 2 – Related data: Statistics on rail delay compensation

One of the complaint categories in this release relates to delay compensation schemes. New statistics published on delay compensation claims data were collected from 2018-19 onwards, and have been published alongside this statistical release since 2018-19 Q2.

The statistics include the volume of delay compensation claims received, closed and approved, as well as the percentage of claims which were responded to within 20 working days. All these measures are provided at national level as well as by each individual train operator.

The United Kingdom Statistics Authority designated these statistics as National Statistics, in accordance with the Statistics and Registration Service Act 2007 and signifying compliance with the Code of Practice for Official Statistics.

National Statistics status means that official statistics meet the highest standards of trustworthiness, quality and public value.

All official statistics should comply with all aspects of the Code of Practice for Official Statistics. They are awarded National Statistics status following an assessment by the Authority's regulatory arm. The Authority considers whether the statistics meet the highest standards of Code compliance, including the value they add to public decisions and debate.

It is ORR's responsibility to maintain compliance with the standards expected of National Statistics. If we become concerned about whether these statistics are still meeting the appropriate standards, we will discuss any concerns with the Authority promptly. National Statistics status can be removed at any point when the highest standards are not maintained, and reinstated when standards are restored.

Our statistical releases hold National Statistics status since being <u>assessed</u>¹ in 2012. Since our assessment we have improved the content, presentation and quality of our statistical releases. Also, in July 2019 we launched our new data portal. We are currently working with the Office for Statistics Regulation (the regulatory arm of the UK Statistics Authority) to conduct a compliance check to ensure we are still meeting the standards of the Code and to therefore reconfirm our National Statistics status.
