# Rail Statistics Management Group – 28 January meeting

The Rail Statistics Management Group (RSMG) is a forum where we discuss our statistics with stakeholders to ensure they continue to meet users' needs and are of good quality. The group also discusses industry research and shares other information and best practice.

#### Rail Fares Index – publication delay

Our rail fares index statistical release is usually published annually in April or May. This release contains information on the annual change in fares applicable from January. Following the Department for Transport's announcement that this year's <u>rail fares rise will be delayed from January until 1 March 2021</u>, this release will be delayed. This is due to fares information not being available until two months later than initially anticipated.

As a result of this delay, as well as the impact of COVID-19 on the revenue weights used in this publication, we are taking advice from other producers of official statistics, our stakeholders and users on our approach to this year's release. # Estimates of Station Usage – National Statistics designation

Following an assessment by the Office for Statistics Regulation (OSR) we achieved National Statistics status for Estimates of Station Usage on 1 December 2020, coinciding with the publication of our 2019-20 statistics. #### **Publication dates**

A reminder that the <u>publication dates</u> for all our statistics are available for the next 12 months. For some releases only the month has been set so far, however the exact date will always be set at least 4 weeks in advance of publication.

To note that the annual <u>Rail Emissions statistical release</u> will be published earlier this year, in August, rather than the usual October/November.
