## Passenger rail service complaints – proposed changes for 2021-22

On 24 June we published our <u>Passenger rail service complaints</u> 2020-21 Quarter 4 statistical release. This included some proposed changes for future publications which we would welcome users' views on.

We are proposing to reduce publication of the following tables from quarterly to annually:

- Appeals closed by Transport Focus and London TravelWatch by operator Table 4163
- Appeals categories closed by Transport Focus and London TravelWatch Table 4160

We are also proposing to no longer produce the following table:

Praise per 100,000 journeys by operator – Table 4123

The reason for these changes is that we have identified low level of demand for these tables from our web analytics. We welcome any feedback on the above proposals to be sent to <a href="mail.stats@orr.gov.uk">rail.stats@orr.gov.uk</a> by 31 July 2021.

### **Descriptive chart titles**

For the first time in <u>Passenger Rail Performance 2020-21 Quarter 4</u> statistical release we used descriptive chart titles. These are designed to provide readers with the main message from the chart. #### New rail station attribute table

We are currently developing a new rail station attribute table which we expect to publish in October 2021 as part of our annual Rail infrastructure and assets statistics for 2020-21. The new table will present geographic and attribute information for each mainline station in Great Britain, including location coordinates, which county each station is in and who manages each station. The table will initially be based on station attribute fields shown in Table 1410 which presents our annual Estimates of Station Usage. If you have any suggestions for additional station attribute fields that you would find useful in this new table or any feedback on the current attribute fields in Table 1410 then please get in touch.

# Office for Statistics Regulation review of accessibility statistics

The Office for Statistics Regulation are reviewing statistics about the accessibility of transport, and want to hear from individuals and organisations using statistics to understand or improve the accessibility of transport.
